FINAL OPPORTUNITY TO REMOVE PERSONAL BELONGINGS FROM CERTAIN STANFORD BRANCH OFFICES

The offices listed below will be closed permanently to former employees. You may access the building to obtain the remainder of your personal belongings, including items you were previously not allowed to remove, at the dates and times designated for each office. If you have receipts for electronic equipment or other items in your office, please bring them with you to expedite this process. Also bring boxes, carts and other assistance, as necessary, to complete the removal of your personal belongings.

Former employees have already been granted access to offices in Atlanta, Asheville, Austin, Baltimore, Baton Rouge (all offices), Boca Raton, Charlotte, Columbus, Dallas, Ft. Lauderdale, Houston (all offices), Greensboro, Jackson, Little Rock, Longboat Key, Orlando, McLean, Memphis, Miami (all offices), Nashville, New York, Richmond, San Francisco, Vero Beach, and Washington D.C. (all offices).

Financial Advisors will be allowed to take documents such as tax returns, wills, corporate resolutions, private placement memoranda, and other documents that are owned by the client but were held by the Financial Advisor for the convenience of the client ("Client Documents"). However, the Financial Advisor must present an original letter of authorization from the client with an original signature before he or she will be allowed to remove Client Documents. Copies or faxes of letters of authorization will not be accepted unless they have been marked with a Medallion Signature Guarantee Stamp from a financial institution receiving the Client Documents. Emails will not be accepted. Additionally, a representative of the Receiver will keep a copy of any Client Document you wish to remove. If you need to obtain Client Documents after the dates listed below, you may submit a request to the Receiver with the client's letter of authorization.
